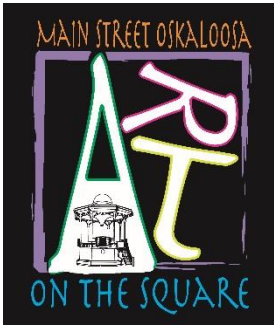

- WHAT:** 49th Annual Art on the Square Outdoor Juried Art Festival
- WHERE:** Our beautiful city park in the center of the **City Square** in downtown **Oskaloosa**
Rain Location: Penn Central Mall (Artists decide by majority vote by 7:30 a.m.)
- DATE:** **Saturday, June 10, 2017 -- 10 a.m. to 4 p.m.** Complimentary coffee & rolls during set up.
(Exhibits must be left in place until closing time.)
- WHO:** **All Artists** with work of their own original design may submit application; only selected artwork will be accepted. Artists accepted last year will not need jury material. No resale items allowed. No artists will be accepted without application, check and (if required) jury material.
- AWARDS:** Several prizes will be awarded by the festival judge: **Various awards will be purchased and eight Awards of Excellence** with no purchase--two at \$200, two at \$100, and four at \$50.

APPLICATION INFORMATION

- 1) **Registration form, jury items and the fee of \$60** (this includes tax) per space is required prior to **April 7, 2017** jury date; after this date of April 7, up to May 12, **fee increases to \$70**. Artwork will be juried on April 10 and May 15, with notification immediately following each juried date. All fees are non-refundable of accepted entries. Early registration is encouraged. Make checks payable to: OACDG, Attn: Oskaloosa Main Street.
- 2) **Note! All artists accepted in 2016 Art on the Square do not need to submit jury material,** right of refusal remains with the committee if exhibits do not meet the requirements for originality. All new applicants will send or bring three (3) items to be juried to: *The Main Street Office* at the address above. Photos (no slides) may be mailed or emailed to khafner@oacdg.org. Where original work is of excessive size or weight must have a detailed description of the medium or materials. May include bio information for publicity.
- 3) Registration fee will be refunded if: submitted work is declined in the jurying process; if space is no longer available; **OR** if there is a need to provide a more balanced and varied show.
- 4) One registration fee covers one (1) walk-through space approximately 12 ft. by 11 ft. situated on concrete walkways. Applicant is responsible for own tables and chairs. No pets allowed. No shelter spaces. If protection from sun or wind is needed, applicant is to be prepared for such. A walk-through space on the concrete walk-way is required by all artists. All artists must supply their own canopy if needed.
- 5) Minimum of 12 art pieces must be available for sale. Committee reserves the right to remove any items from the show that do not meet juried expectations.

- √ **\$1,000 in Award Prizes:** Eight Awards of Excellence with no purchase will be awarded-- two at \$200, two at \$100 and four at \$50 each. Various Purchases Awards to be announced.
- √ **First Jury Date:** April 7 is the first jury date for artists. If you were accepted in the 2016 show, jury material is not required but **check and application are required**. May 12 is the final jury date. All artists will be notified of acceptance immediately following each jury date. No applications will be accepted after May 12. No artists will be considered without a complete application, check and (if needed) jury material.

RETURN ENTIRE LOWER PORTION -No artists will be considered without complete application, check and (if needed) jury material. Please return by April 7, 2017! Charge for late fee after this date.
